<sup>1</sup> Under the Criminal Records (Clean Slate) Act 2004, you do not need to declare your New Zealand conviction if all the following apply: (a) It has been 7 or more years since your most recent conviction and you have not reoffended; and (b) You have never had a custodial sentence imposed upon you; and (c) You have never been detained in hospital by Court order instead of receiving a sentence; and (d) You have never been convicted of a sexual offence; and (e) You have paid any fines/costs/compensation/reparation; and (f) You have not been disqualified from holding or obtaining a drivers licence indefinitely.
