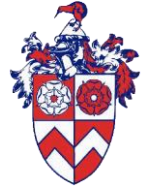

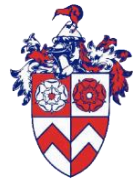
Thank you for applying for a position with our school. Please ensure you have a copy of the job description and person specifications before completing this application.
